#### **OLD BUSINESS:**

The Finance Committee of Chairperson-Nathan Yoder, Adam Kocher and Mayor, Ben Gilbert met and presented to council ideas and rates to invest the current savings account funds into CD's. The committee contacted the following banking institutions: First Commonwealth Bank; Muncy Bank & Trust Co.; and Turbotville National Bank. Rates for First Commonwealth Bank were- 11, 12, 18 or 20 months at rate of 3.85% or 24, 26 or 30 months at rate of 3.70%; MB&T Co. 13 mo-4.30%, 18mo. at 4.25%, 30 mo. at 4.20% or 36mo. at 4.00; TNB came in with 13mo at 4.60%, 18mo. at 4.39% or 30mo. at 4.35%. Upon suggestion, Nathan Yoder will check back with bank to verify FDIC insurance coverage on amounts over 250,000 and that the quoted rates cover the duration length of each CD rate. Agreed upon investment was with Turbotville National Bank with 13mo. 4.60% invest \$300,000; at 18 mo. Rate of 4.55 invest 200,000; at 25 mo. at 4.39% invest 100,000; and at 30 mo. 4.35% invest \$100,000, for total investment amount of \$700,000.00 from savings to CDs.

A motion was made by Nathan Yoder and seconded by Betty Figels to accept the proposal given by Turbotville National Bank for our CDs. A roll call vote was taken as follows:
